 - *Are we monitoring water usage to charge based on this in the future? Yes we are monitoring, but not basing water charges on this fact.*
 - *John F sent in a question on capital budget. Is it necessary for us to replace the two older trucks we have? Have we considered keeping the older trucks going? Both trucks are 25 years old and in poor condition. It's in the long range plan to replace in 2025 so we are proceeding with evaluation. We may keep the white truck, but replace the black one. Within our budget we can replace it and get another snow plow too.*
